

Approving the Debtors' Amendment to Security Agreement and Extension and Confirming Grant of Lien on the Stock of the Debtors' Foreign Subsidiaries, dated November 17, 2008 (the "Brief"). As grounds for this Motion, the Committee state as follows:

1. The Committee's Brief includes material that the Debtors deemed to be confidential information ("Confidential Information") pursuant to the terms of the Stipulation Between the Debtors and the Official Committee of Unsecured Creditors of Propex, Inc. et al., Regarding Confidential Information (the "Stipulation Order"), executed by the parties on February 21, 2008 and so-ordered by the United States Bankruptcy Court for the Eastern District of Tennessee (the "Bankruptcy Court") on February 27, 2008.

2. Good cause exists for the relief requested herein for the reasons stated in the Court's Order providing for filing documents under seal entered in this case on November 5, 2008.

WHEREFORE, the Committee respectfully requests the Court to enter an Order permitting it to file its Brief under seal. A copy of the Reply Brief in Support of the Official Committee of Unsecured Creditors of Propex Inc.'s Appeal of the Order Regarding the Debtors' Motion for an Order Authorizing and Approving the Debtors' Amendment to Security Agreement and Extension and Confirming Grant of Lien on the Stock of the Debtors' Foreign Subsidiaries will be hand delivered to the Clerk of the United States District Court for the Eastern District of Tennessee at Chattanooga to be filed under seal.
