**ORDER APPROVING FIRST INTERIM APPLICATION OF BAKER,  
DONELSON, BEARMAN, CALDWELL & BERKOWITZ FOR ALLOWANCE  
AND PAYMENT OF COMPENSATION AND REIMBURSEMENT OF  
EXPENSES FOR THE PERIOD JANUARY 31, 2008 THROUGH AUGUST 31,  
2008**

The First Interim Application of Baker, Donelson, Bearman, Caldwell & Berkowitz (“Baker Donelson”) for Allowance and Payment of Compensation and Reimbursement of Expenses for the Period January 31, 2008 Through August 31, 2008,

came before the Court on October 15, 2009 (the "Application"), and there being no objections to the Application and for good cause shown, the Application is approved, and it is ORDERED THAT:

(a) Baker Donelson is allowed \$67,935.00 for interim compensation for professional services rendered to the Committee during the period from January 31, 2008 through and including August 31, 2008;

(b) Baker Donelson is allowed reimbursement of its out-of-pocket expenses incurred in connection with the rendering of such services during the period January 31, 2008 through and including August 31, 2008 in the amount of \$467.08;

(c) The Debtors are authorized to pay Baker Donelson \$30,348.02, the unpaid portion of Baker Donelson's interim fees and expenses that have been approved and allowed.
